SGA FACTS

What is the Student Government Association (SGA)?

SGA is a body of students elected by their peers to serve as their voice on campus, by promoting campus involvement, fostering leadership development, overseeing and assisting in the development of student clubs and organizations, and by acting as a liaison between student organizations and campus administration.

Who's on this team?

The <u>SGA Executive board</u> is made up of five elected officers and one appointed officer. There are also five elected senator positions.

The <u>SGA Council</u> is comprised of student organization representatives and any registered full or part-time student at Davidson County Community College.

What do we do?

The SGA is an umbrella organization for all student clubs and organizations and we serve to provide students with cultural, social, recreational, and service oriented activities throughout the year. Some events include fall and Spring Festivals, Halloween Extravaganza, Welcome Back Bash, Spring Dance, Adopt-a-Highway, community service events and food, book and Red Cross Blood drives.

Here's how Student Government represents the student body:

1. They maintain and exercise their voice in all the student oriented issues and consistently strive to develop the student's needs, wants and ideas.

2. Serve on advisory committees that cover goals and objectives of Davidson County Community College campus-wide policies.

3. Provide a Student Forum for the student community to come and voice their opinions.

4. Actively pursue student issues and promote activities related to the increased success of the student community.

What are the benefits?

As an SGA Officer or Senator you have the opportunity to build leadership and communication skills, learn work-related responsibilities, gain skills in parliamentary procedures, attend statewide conferences, and network with other students at home and across the state. Our SGA is a member of the North Carolina Comprehensive Student Government Association (N4CSGA) which holds two conferences every year. Delegates attending the conferences have the opportunity to elevate state wide student concerns which are presented to our state legislators to help effect positive change for all community college students. The SGA officers and senators can be recognized on campus by the distinctive shirts that they are routinely seen wearing as they work to make DCCC a better place to think, learn, and interact. The leadership experience gained and friendships found in the SGA will last a lifetime.

Qualifications for Student Government Association Officers

- 1. A candidate must be in good academic standing, enrolled at least half-time (6 credit hours) and have and maintain a minimum GPA of 2.5 or better. GPA will be verified each semester.
- 2. A candidate must have at least two remaining semesters at DCCC.
- 3. A candidate can only serve a maximum of two terms in the SGA. A term shall consist of two consecutive semesters. SGA officers must change positions in their second term. SGA officers seeking re-election will undergo a performance evaluation to determine their readiness for re-election.
- 4. A candidate must be in good standing at the college with no history of any Student Code of Conduct violations during their academic career at the college.
- 5. No candidate shall run for more than one office at a time. Once an application has been submitted to the SGA Advisor, the candidate cannot change the title of the office in which the candidate intends to run for.
- 6. A candidate must agree to abide by all policies and procedures as stipulated by the Director of Student Life and Leadership/SGA Advisor.
- 7. Each potential candidate must complete an application (available only in the Office of Student Life and Athletics, BSC 131), which must be returned to the SGA Advisor by the posted deadline. <u>No exceptions will be made to this policy.</u>
- 8. Each candidate will undergo an interview process with the SGA Advisor and/or Dean of Student Support and Campus Life.
- 9. A candidate must agree to attend mandatory SGA officer and leadership training including conferences and divisional meetings.
- 10. Each candidate will be required to provide a photograph. Your photograph should focus on your head and shoulders. Please download a photo to me at lmwatts@davidsonccc.edu by the SGA application deadline.

Campaign Rules & Suggestions

- Official campaigning (posting campaigning flyers, distributing literature, etc.) will take place from March 28 to April 20.
- You are expected to run a POSITIVE campaign promoting your own candidacy.
- Negative campaigning against other candidates is not permitted and will result in the termination of one's candidacy. This is true of "unofficial campaigning such as talking about and /or spreading rumors or coercing students to vote for you. Any of these actions will result in automatic disqualification from the election.
- The campaigning objective is to meet as many of your fellow students as possible. You will want them to be familiar with your name, face, and background.
- Get to know the Student Government Association and its strengths and weaknesses. You will want to be able to have meaningful conversations that show others you know what you are talking about.
- Wear a lapel badge announcing in bold print that you are a candidate during the official campaigning period (March 28-April 20).
- Make personal contact with as many voters as possible. Think of yourself as a product that you must "sell" to the student body. Talk to friends, casual acquaintances, classmates, and strangers. To help make the impression last, leave each voter a piece of campaign literature containing your name and a brief summary of who you are and what you ideas are.
- Request a visit with student organizations to promote your candidacy.

Election Postings/Flyers

- Campaign flyers or posters should not be offensive, derogatory or with malicious intent toward another candidate and should be posted in accordance with DCCC poster policy. Posters should not be placed on top of existing school information.
- There is to be no tampering with any candidate's flyers or poster. If you notice anyone tampering with, removing or destroying any campaign poster, please contact the SGA advisor immediately. Any candidate caught/linked to tampering or destruction of another candidate's posters will be disqualified.
- There is a maximum of three posters allowed per building.

- Students may wear campaign button, stickers, etc. anywhere on campus throughout the campaign period (March 28-April 20).
- All posters MUST be removed by 5 p.m. on the final day of the election. It is the responsibility of the candidate to see that his or her materials are removed.
- Each candidate for any office shall be responsible for campaigning expenditures.
- Each candidate is allowed to have one flier posted at the ballot box on the election days.
- All campaign material must be removed by the closing of the final Election Day.
- The Student Life Office reserves the right to remove any flyer/poster that they feel is inappropriate or violates election rules.

Voting Procedures and Election Day Results

• Students may cast their votes at one of the following times:

April 20 from 10-2 p.m. and 5-7 p.m. in the Courtyard /Office of Student Life

April 21 from 10-2 p.m. and 5-7 p.m. in the Office of Student Life.

- Only students with a valid DCCC ID are permitted to vote. Each voter must sign the registration sheet when receiving the paper ballot.
- Completed ballots are to be placed in the locked ballot box. The ballot box will remain sealed until all votes have been cast.
- Once a student votes, his or her name will be crossed off so the student cannot vote again.
- Voters who are absent from school on the two election days will not be permitted to vote by alternate means.
- No candidates are allowed within 25 feet of the election polls at any time while the poll is open.
- Once all votes have been cast, the votes will be tabulated by independent auditors. A general announcement regarding the outcome of the election will be made the next day after the elections.
